Jefferson Borough is currently amending the ADU ordinance to remove the requirement that occupants be certain family members. They are also allowing children to reside in the ADU so the ADU can be used through all stages of life.

				Our continued partnership with Woda Cooper Development is expected to produce a 43 one-and-two apartment complex for persons age 62 and older in Dallastown Borough. Settlement is expected in June with construction expected to begin immediately afterward.
				Additionally, as part of the Pleasant Acres Annex project, we are anticipating that funds will be requested to support the rehabilitation of the existing building into 50 efficiency style and one bedroom units for persons age 62 and older. Going forward, we are going to survey several of those members to try to determine what is keeping them from participation. Maybe if we can identify those barriers, they can be addressed. We have a good network to help us to market the

				program, but something is not connecting. One of the other strategies we talked about is creating a database of medical professionals (GP's) and getting the information out to them, so they are able to refer patients.  I will continue to keep you updated on our progress. We are totally committed to providing this program for the community, so we will continue to work hard to determine other ways to encourage participation.
