When you establish a Fund for York County, your gift addresses a broad range of local needs - including future needs that often cannot be anticipated at the time your gift is made. York County Community Foundation evaluates all aspects of community well-being: arts and culture, economic development, education, environment, health and human services, neighborhood revitalization, and more. The flexibility of your unrestricted gift enables YCCF's program experts to respond to the community's most pressing needs, today and tomorrow.

#### **How it works**

- You make an unrestricted gift to York County Community Foundation during your lifetime or through a bequest in your will. You can give cash, appreciated stocks, real estate, or other assets.
- YCCF sets up a special fund in your name, the name of your family or business, or in honor of any person or organization you choose.
- You receive tax benefits in the year your gift is made.
- Our professional program staff determines the areas of the community need that would be most impacted by grants from your gift.
- YCCF handles all the adminstrative details and our board awards grants in the name of the fund you establish (if you prefer, grants can be made anonymously).
- Your fund is an endowment that is invested over time. Earnings from your fund are
  used to make grant addressing community needs. Your gift and all future earnings
  from your gift is a permanent source of community capital, helping to do good
  work forver.
